Valid January 1, 2025 – December 7, 2025 or until funds are depleted.

### Please verify that the following requirements are met before submitting your application.

1. Must be a residential water customer of the Metropolitan Utilities District.
2. Shut-off device or Wi-Fi sprinkler controller with predictive watering integration **must be installed by a professional sprinkler irrigation technician. No self-installation.**
3. **PROOF OF PURCHASE** (invoice or paid receipt) from an irrigation company, must be provided with this form.
4. **PROOF OF PURCHASE** must show address where the product was installed.
5. Rebates are eligible for one rain sensor shut-off device or one Wi-Fi sprinkler predictive controller per account. Only one device will apply per account. It does not apply to new construction.
6. All applicable fields must be completed on this form to receive a rebate. Incomplete rebate forms will not be processed.
7. Rebate offer for purchases made between January 1, 2025 – December 7, 2025.
